#### **ACFHP SAV Seed-Transfer Guidance Document**

- Developing a Guidance Document on interstate and regional seed-transfer practices for SAV, focusing primarily on *Zostera marina* (eelgrass), as well as *Ruppia maritima* (widgeongrass).
- Will compile and synthesize the latest science and BMPs to support seed-based research, restoration, and management.
- Serves as a resource for agencies and organizations considering policy or regulatory decisions.
- Developed through a multi-step process:
  - 1. Literature review and synthesis
  - 2. Zosterapalooza Secession
  - Invitational workshop (ACFHP-hosted)

## **Process & Preparation**

### **Step 1: Literature Review and Synthesis**

- ACFHP will release a RFP seeking contractor(s) to conduct a literature review and produce a report that summarizes and synthesizes info:
  - frameworks for assisted migration and local adaptation of species (including from other systems),
  - seed collection, storage, handling, and transfer practices,
  - other topics as identified by the workshop planning and the dedicated session as Zosterapalooza

## **Process & Preparation**

## Step 2: Zosterapalooza Session (March 26, 2026)

- Day two of the 35'th annual Zosterapalooza (March 25-26, 2025),
   Boston, MA
- Sesson includes scientific presentations and discussion aimed at large scale seed-based restoration
  - Including challenges, questions, and potential BMPs.
  - These BMPs will be further developed and evaluated at the invitational workshop into the Guidance Document.

## **Process & Preparation**

#### Step 3: Invitational Workshop (Fall 2026)

GOAL: Refine and finalize BMPs for inclusion in Guidance Document.

#### OBJECTIVES:

 To review information and draft BMP concepts identified and developed at Zosterapalooza and finalize BMP recommendations for inclusion in the Guidance Document.

#### EXPECTED OUTCOMES:

- Detailed workshop summary report (finalized within a month of the workshop)
- ACFHP Guidance Document (finalized a few months after workshop)
- Publication in a journal (1-2 years after workshop)
